Deposit (NON-REFUNDABLE and NON-TRANSFERRABLE)

Deposit is to confirm the admission offer. Since there are applicants on the waiting list and there is quota for each program, it is very important to confirm the offer and settle all required fee on time.

Program fee (NON-REFUNDABLE and NON-TRANSFERRABLE)

The program fees of 2025 Fall term intake of MSc in Environmental Engineering and Management for full-time mode is HK\$186,900(in 2 installments) and part-time mode is HK\$162,800 (in 4 installments) respectively. Program fee is required to be paid before stipulated deadlines.

The program fee of 2025 Fall intake of Postgraduate Diploma in Environmental Engineering and Management for full-time mode is HK\$93,450 (in 1 installment) and part-time mode is HK\$93,450(in 2 installments) respectively. Program fee is required to be paid before stipulated deadlines.

Program fee is non-refundable and non-transferrable. Students admitted with credit transfer are also required to pay the full program fee.

The program fee covers registration for a total of ten (five) 3-credit courses including transferred courses in the nominal period of respectively four and six (two and three) terms for full-time and part-time MSc (full-time and part-time Postgraduate Diploma) students.

Students who need to repeat a course or take course beyond the nominal period (subject to approval) or take extra course beyond the total credit requirement (including transferred course) will have to pay extra for three credits of HK\$18,690 for MSc full-time mode, HK\$16,280 for MSc part-time mode, HK\$18,690 for PGD full-time mode & HK\$18,690 for PGD part-time mode.

Note that both the deposit and the program fee will not be refunded under any circumstances.

Caution money (*Fee for Fall 2025/26 is subject to review.)

The caution money of HK\$400 is required to be paid by student on the first registration. Charges will be made against this deposit if there are any unpaid claims against the student, such as outstanding library dues. At graduation, the student is required to restore the balance of the caution money to its original level and the full amount of the caution money will be transferred toward the graduation fee.

Medical Insurance for non-local students (*Fee for Fall 2025/26 is subject to review.)

The University policy stipulates that compulsory medical insurance is required for all full-time degree-seeking non-local undergraduate and postgraduate students studying at HKUST on student visa/entry permit. Details please refer to the web page at <https://sfao.ust.hk/individual.php?l=30>
